# Background

- Pilot projects were evaluated by the BMPVAHAT
  - Recommended that AgWG is briefed on results
- BMPVAHAT = BMP Verification Ad-Hoc Action Team
  - August 2020 – September 2022
  - Charged with exploring alternatives to BMP re-verification, reassessing established credit durations, **exploring lesser-used approaches to BMP verification**, and reviewing recommendations from ongoing BMP verification work

# Agriculture Advisory Committee Update

- July 28, 2023 – State Ag. Secretaries and Commissions for Bay states sent letter to EPA Regional Administrator Adam Ortiz recommending the formation of an Ag. Advisory Committee
- September 26 – PSC discussed the recommendation
- October 19 – PSC chair informed Executive Council that the PSC will empower an Action Team to develop directive for the EC to consider
- December 8 – PSC action: **Establishment of a Chesapeake Bay Watershed Agreement Action Team to Pursue the Formation of an Agricultural Advisory Committee to Chesapeake Executive Council**

# Agriculture Advisory Committee Update

- Action Team is responsible for recommending whether or not an Agriculture Advisory Committee should be established
  - Recommendation finalized by 2024 EC meeting
- Action Team will provide updates to PSC
  - We will keep AgWG informed
- Limited information at this time, as Action Team is newly formed

# Beyond 2025 Update

- 2022 EC charge to PSC: recommend “a critical path forward that prioritizes and outlines the next steps for meeting the goals and outcomes of the Watershed Agreement leading up to and beyond 2025.”
- March 2023 – MB approved formation of Beyond 2025 Steering Committee
  - Members from bay jurisdictions, fed. agencies, GITs & advisory cmtes
  - Steering committee met June - October
- October/November 2023 – Small groups formed
  - **Clean Water**, Climate, Healthy Watersheds, People, Shallow Water Habitats
