Delaware County Statistics

- South-East New York, Base of the Catskill Mountains
- 1,500 Sq. Miles of Land 25 Sq. Miles of Water Resources
- 145,000 acres involved in production agriculture
- Agriculture generates nearly \$50 Million of income annually
- Land base ideal for grazing operations
- 130 Dairy Operations (Avg. Herd Size 75)
- 200 Beef & Livestock Operations (Avg. Herd Size 50)
- 235 Active CRP/CREP Contracts
 - 57 Re-enrollments to Process for 2016
 - 21 Re-enrollments to Process for 2017

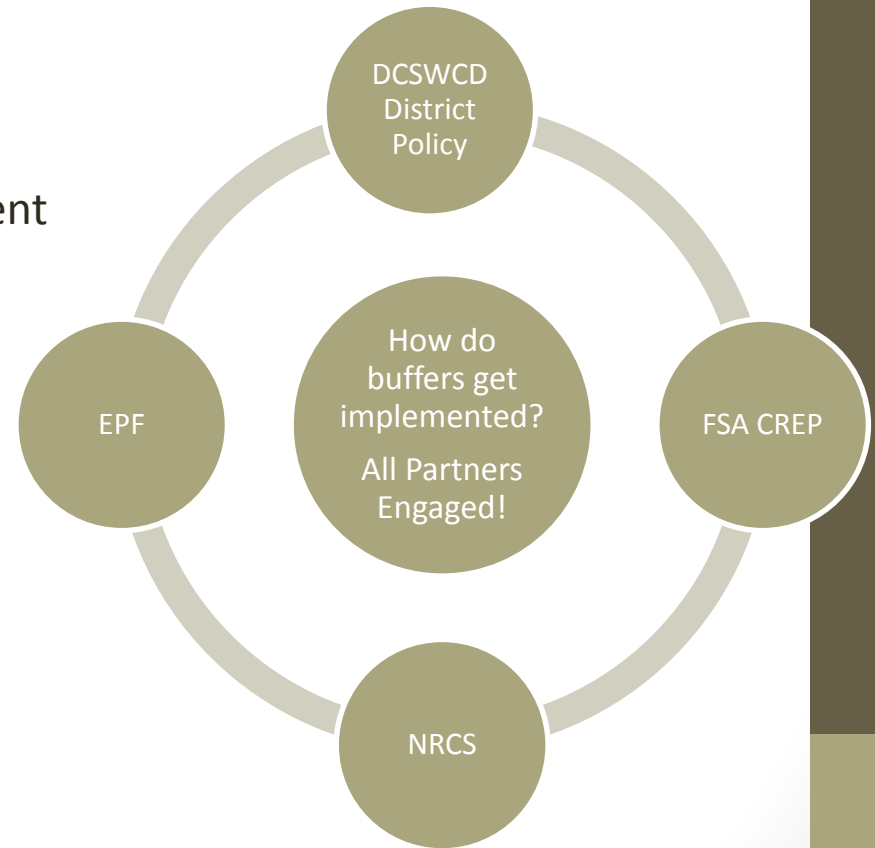
SWCD Livestock Exclusion Policy:
