- *“I haven’t received help/ the HGIT isn’t helpful” – 3 responses*
- *Improved leadership/communication*
- *Identified other relevant work for follow-up efforts*
- *Keeps us focused*
- *Informs what others are doing*

How has the HGIT helped your workgroups since the last meeting (November 2023)?

- *“Not sure” – 2 responses*
- *Continue to provide funding connections*
- *Help support Habitat Tracker/data-submitters*
- *Continue to advocate for workgroup priorities (projects & activities)*
- *Facilitate coordination between groups*
- *Identify opportunities to increase capacity to advance workplan*
- *The HGIT Workgroups should go beyond species-only approaches (focusing only on specific populations) and should instead focus more on the ecology of the larger habitats/ecosystems.*

- Needed to prioritize output and outcomes.
- Helped with the update of our workplan. Very helpful in encouraging us to think about how we make DEIJ part of our SOP.

■ *“No” – 1 response*

- It seems like the other way around – WG priorities inform the HGIT strategy

■ *“Not sure” – 4 responses*

- *“Yes” – 3 responses*
- *“No” – 2 responses*
- *“Sometimes” – 2 responses*

- *“No change” – 1 response*
- *Be more clear definitions (e.g., difference between CBPO & “The Partnership”)*
- *Incorporate Accessibility into DEIJ practices*
- *Cross-GIT/Workgroup Coordination should be increased*
- *Move social science into near-term priorities*
- *Habitat effects on living resources should be a priority (e.g., how different living shoreline approaches affect multiple goals simultaneously)*

What priorities should be added to the HGIT Management Strategy?

- *“Not sure” – 2 responses*
- *“None” – 3 responses*
- *DEIJ – 2 responses*
 - *DEIJ doesn't fit under all workgroup “priorities”*
 - *Concerns w/DEIJ being listed under “long-term” = when is it intended to be used?*
- *Warm water stressors (can be addressed through riparian buffers)*
- *Tool Support (reduce focus on supporting existing, specific tools and focus more on developing new tools that address questions we've yet to tackle)*

What priorities should be removed from the HGIT Management Strategy?

- *Request to keep biannual HGIT meetings to two half-day meetings (preferred over one long day)*
- *Requested additional time for workgroup updates & general Q&A*
- *Request for the HGIT Management Strategy to be restructured to include more specific action items with a definitive timeline*
