Over the last year contractor Skeo and an advisory team have been working to research various potential approaches, and associated resources required, for an updated, watershed-wide dataset of important habitat to guide land conservation and terrestrial and aquatic habitat conservation, restoration, and stewardship. Skeo will give a presentation to the HWGIT about their findings and potential next steps.
