The Fish Passage Workgroup, including State Fish Passage Coordinators, cannot commit to complete monitoring in this manner due to limited resources and high costs. The workgroup is happy to provide STAC a presentation on monitoring activities related to dam removal, including both short term and long term monitoring sites.</p>
