I am pleased to announce the Office of Research and Development's (ORD) second annual solicitation for proposals for the Regional-ORD Applied Research (ROAR) program. The ROAR program is a mechanism to advance collaborative ORD and regional research partnerships that address high priority near-term Regional, State, Tribal and strategic Agency research needs. FY22 was the pilot year for the [ROAR program](#). ROAR integrates previous ORD/Regional collaborative research programs ([RARE](#), [RESES](#), and [RSTIP](#)). ROAR provides an opportunity for ORD and regional staff to collaborate on research projects that address priority regional research needs across a wide range of environmental issues.

The ROAR program is supported by ORD and addresses regional science needs across the entire range of environmental and public health issues for which ORD has expertise and capabilities. This includes research on the health and environmental effects of contaminants, exposure and risk assessment, analytical methods development, environmental justice and community issues, and scientific and engineering solutions to environmental stressors, including chemical stressors, nonchemical stressors, and climate change.

Working with the ORD Office of Science Advisor, Policy and Engagement (OSAPE), Regional Science Liaisons (RSLs) will coordinate the ROAR processes in each Region. The RSLs can assist Regional staff in identifying ORD scientists to partner with Regional scientists in developing proposals.

All proposals must align with the [FY22 – FY26 EPA Strategic Plan](#), [ORD's draft FY23-FY26 Strategic Research Action Plans](#) for its national research programs, and the Administrator's priorities. We are particularly interested in supporting projects with state, tribal, or community partner engagement and/or projects using innovative research approaches. Please consider state science priorities, as well as the needs of our tribal and community partners, as Regional and ORD teams develop proposals.

Regions may submit ROAR proposals that will be reviewed and selected through one of the three following funding selection tracks. Selections are subject to the availability of funds.

- *OSAPE Track* – Each Region may submit up to two proposals nominated for consideration under OSAPE’s strategic selections. This year, proposals in this track should address one or more of the following topics: innovative research that addresses environmental justice and/or climate change issues and their impacts to States, Tribes, or communities. Proposals received for this track will be reviewed by an ORD/Regional relevancy review team and selected by OSAPE’s Director. Anticipated funding for FY23 is \$800K, to be allocated among selected projects. This funding will be provided by OSAPE.
- *SHC Track* – Proposals submitted to the Sustainable and Healthy Communities (SHC) Track must align with at least one of the three Topics of the ORD SHC Research Program portfolio: (1) advancing remediation and restoration of contaminated sites; (2) materials management and beneficial reuse of waste; and (3) integrated systems approach to building healthy and resilient communities. Projects will be selected for funding by the National Program Director for SHC. Anticipated funding for FY23 is \$600K-\$700K, to be allocated among selected projects. This funding will be provided by the SHC program.
- *Regional Track* – Proposals submitted to this track support applied, near-term Regional research needs and are selected by each Region. Anticipated funding is \$260K per Region. This funding will be provided by OSAPE.

**ROAR Proposals will be due to ORD by October 28, 2022.** The schedule for the program is attached for your reference.
