<b>10:15</b>	<b>Tracking Status and Trends in Seven Key Indicators of River and Stream Condition in the Chesapeake Bay Watershed; <i>Presenter: Rosemary Fanelli and Lindsey Boyle (USGS)</i> – 45 min.</b> This presentation will summarize initial results from a multi-year effort to quantify status and trends in seven indicators of stream health in the Chesapeake Bay watershed (aquatic communities, streamflow, water quality, hydromorphology, water temperature, salinity, and toxic contaminants).
