*Announcements:*

- The deadline to apply for FY2019 STAC Workshop funding has been extended to Friday, February 22.
- The deadline to update the management strategy and logic table for 2017 WIPs, 2025 WIPs, and Water Quality Standards Attainment and Monitoring has been extended to April 19, 2019.
- Opportunity for WQGIT members to raise again any immediate Partnership needs and challenges following the federal shutdown and partial lapse in federal funding that may impact priorities and schedules.
- Following the partial lapse in federal funding, deadlines for final changes to draft 2018 progress scenarios have been extended to Friday, February 22. There will be additional model runs for jurisdictions of their draft versions of 2018 Progress COB Fridays on 2/8/19, 2/15/19, and 2/22/19 – if there are changes to data submissions since the previous run.

1:20 Combined Sewer Separation Load Reductions in DC's CAST scenarios -Gary Shenk, USGS, Jonathan Champion, DOEE, James Davis-Martin, VA DEQ

Clarification of the proposed resolution to CSS load reductions in DC assigned to federal agencies. This change would only affect CSS reductions in one facility in DC and does not affect jurisdictions outside DC. VA representatives will also present a WTWG-

approved proposal to allow for combined sewer separations to be designated as non-regulated developed land in addition to current conversion to MS4.
