Wastewater

Watershed Technical

Workgroup updates – more details

Agriculture

- The AgWG met on December 18th. This meeting included program updates, a presentation on the preliminary mapping to BMPs and load source groups, an update on the methodology for the allocation of feed space acres for Phase 7, and a discussion on priority BMPs for efficiency evaluation and remote sensing.
- The AgWG will meet again on January 29th (rescheduled from January 15th). At this meeting, the AgWG will review and approve an updated matrix mapping BMPs to load sources, including a list of ag BMPs mapped to solar land uses, before the WTWG votes on its final approval. The group will also receive introductions from nominees for the At-Large and Vice Chair positions, a refresher on the E3 Scenario, and an overview of Water Quality Monitoring efforts in York County, PA. The process for confirming At-Large and Vice Chair positions is paused until additional guidance is received.

Forestry

- **Relevant note: CSS Harvested Forest for Phase 7** - To implement the Timber Harvest Task Force Recommendations (approved by the FWG and the WQ GIT), Phase 7 will include a new “CSS Harvested Forest” land use.
- This land use would only apply if: (1) harvested forest is mapped within the CSS footprint or (2) in the rare circumstances where a given modeling segment does not have sufficient non-CSS harvestable forest (forest patches >10 acres) to apply the amount of harvested forest allocated to that modeling segment. In the case of option 2, CSS Harvested Forest would be pulled from CSS Forest, so if these acres were not needed to meet that modeling segment’s proportional allocation, they would remain as CSS Forest.
- The same BMPs can be applied to both.

Urban Stormwater

- USWG met Dec 16th and approved an adjustment to the Compacted Pervious Land Use class. They discussed a decision on the mapping of developed BMPs to Load Sources and finalized it via email on Jan 20th.
- Members also heard a presentation on the “Beyond Bean Counting” draft report and provided feedback for the final report.

Watershed Technical

- In December, the WTWG voted via email to approve the proposed methodology for allocating feed space acres for Phase 7.
- The WTWG met on January 8th and heard introductions from Vice Chair and Chair nominees, a presentation on new Progress data storage policies, an update on the mapping of BMPs to load source groups, and an initial look at the draft Phase 7 NEIEN Appendix. The group will pause the confirmation of nominations for vacant Chair, Vice Chair, and At-Large positions until additional guidance is received.
- The WTWG will meet again on February 5th to approve the mapping of BMPs to load sources, discuss updates to the Progress Validation Report, review the draft NEIEN Appendix and a proposed update to Animal Waste Management Systems, and receive an overview of the E3 and No Action Scenarios.

- Update on the review of the draft time series data:
- In the last week of January, Sarah McDonald will be holding meetings with the Jurisdictional representatives to get preliminary feedback on the Time Data Series. Early February will be a rolling test of the web viewer by county, with test counties posted on the updated web viewer as they become available. Office hours will be held on March 3rd for review of updated data and questions. By March 13th, all county data will be reviewed with partial documentation.
