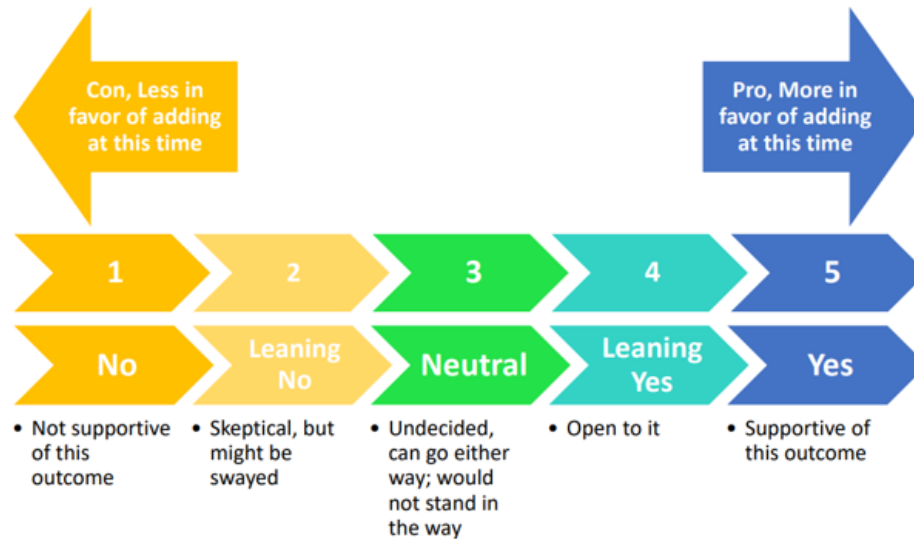


**Water Quality Goal Implementation Team (WQGIT) Signatory and At-Large Member
