**Commented [PL1]:** PADEP Comment: The Management Strategy states “that these entities must continue to work towards strengthening and sustaining adequate capacity necessary to complete the efforts through the Phase III WIPs and future two-milestones” While we are collectively working toward that end goal, financial support for “boots on the ground” has not met the need. The challenges for technical assistance toward BMP verification and implementing new BMPs have been quantified in PA’s Phase 3 WIP.

I am unsure what the definition of “minor obstacles” are, but this should be in red, due to the enormous workload across all Bay jurisdictions.

Metric exists: Consistent grant administration is one measure of progress. The need is for increased funding for personnel, subawards for technical assistance, and education and outreach. Grant coordination across multiple federal and state sources must be considered.

Expected response and application: Not understanding the example provided under this category. This doesn’t address the factor.

Learn/adapt does not address the factor.

**Commented [PL2]:** Technical assistance gaps remain - particularly in the ag sector where higher levels of implementation are planned and expected - and states are experiencing resource and technical challenges with implementing BMP verification programs. However, work continues to move forward on better quantifying co-benefits. Increased funding toward Bay grant programs.

How costs might be reduced by more cost-effectively reallocating nutrient and sediment reductions among source sectors also needs to be re-evaluated (CAST). This factor is called "delivering the necessary financial capacity to implement". This delivery has not occurred, nor does it seem to be on track.

Expected Response: does not make sense as related to the factor. Specific example provided by MD is unclear how it connects.

**Commented [PL4]:** Funding gaps vary amongst state and local jurisdictions, but more financial resources are needed in some areas to meet implementation goals by 2025. Work and support continues to target funding towards priority watersheds and practices. Discussions are underway to leverage other sources of (federal) funding (e.g., NRCS). Conowingo WIP financing strategy may serve as a model for private sector investments in water quality improvements.

To my knowledge, the only BMP in the model that has been accelerated has been the urban stream restoration due to the creative approach of using protocols.
