- Matt will explain that states have the opportunity to update 2006 through 2009 data in NEIEN directly for 2014 Progress. To enable this, states and the CBPO could work with Tetra Tech to convert their 2006-2009 implementation data into XML. The states would then be able to edit the XML as they see fit, create a new XML, or submit the existing XML to NEIEN. This gives states the flexibility of editing their most recent history directly, by year. The remaining history (1985-2005) would remain in Scenario Builder and be used for each upcoming Progress run until the next version of the model, but states and the CBPO could also work with TetraTech to edit this data and convert it to XML as part of the historical BMP clean-up process.
