

Designing Phase III WIP Point Source Scenarios (in three parts)

Part 1: Initial Draft Phase III WIP Point Source Scenario Development

Description: Each jurisdiction will have the opportunity to create and post one, but only one, initial draft Phase III WIP point source scenario for CAST users.

Deadline: No deadline; jurisdictions may work on this phase between now and April, 2019.

Step 1: Download 2017 Progress V9 point source input file from CAST.

Step 2: Work with Sucharith Ravi and the CBPO to revise point source input file between now and April, 2019.

Step 3: Approve changes to point source input file, and request its posting on CAST.

Step 4: CBPO will post initial draft Phase III WIP point source scenario to CAST prior to April, 2019 as requested by jurisdiction.

Part 2: Draft Final Phase III WIP Point Source Scenario Development

Description: Each jurisdiction will be expected to create one, and only one, draft final Phase III WIP point source scenario for release with their draft Phase III WIP in April, 2019.

Deadline: April 12, 2019

Step 1: Download your initial draft Phase III WIP point source input file from CAST (this is the one that jurisdictions will complete between now and April, 2019).

Step 2: Work with Sucharith Ravi and the CBPO to revise point source input file between now and April, 2019.

Step 3: Approve changes to point source input file, and request its use in your draft Phase III WIP due April 12, 2019.

Step 4: CBPO will combine ALL jurisdictions' point source files into one watershed-wide draft final Phase III WIP point source scenario, and will release to CAST following the April 12, 2019 deadline.

Part 3: Final Phase III WIP Point Source Scenario Development

Description: Each jurisdiction will be expected to create one, and only one, final Phase III WIP point source scenario for release with their final Phase III WIP in August, 2019.

Deadline: August 9, 2019

Step 1: Download your draft final Phase III WIP point source input file from CAST (this is the one that will be posted on CAST in April, 2019).

Step 2: Work with Sucharith Ravi and the CBPO to revise point source input file between April, 2019 and August 9, 2019.

Step 3: Approve changes to point source input file, and request its use in your final Phase III WIP due August 9, 2019.

Step 4: CBPO will combine ALL jurisdictions' point source files into one watershed-wide final Phase III WIP point source scenario, and will release to CAST following the August 9, 2019 deadline.

So, to recap, jurisdictions will have the ability to develop and post three point source scenarios for the Phase III WIP between now and next August. Additional spreadsheet scenarios could absolutely be developed between jurisdictions and the CBPO, but would not be released to the general public on CAST. The primary purpose of this approach is to avoid the creation of tens or hundreds of scenarios between now and next August when the WIPs go final. That would confuse all users, and the CBPO

believes most of the revisions necessary to point source inputs can easily be done in spreadsheets without the need to post multiple revisions to CAST.
