

ACTIONS

- Beyond 2025 Charge
 - Will direct the Principals' Staff Committee to take the following actions:
 - Revise the existing Chesapeake Bay Watershed Agreement by the end of calendar year 2025.
 - Develop a simplified and streamlined structure and process for the partnership that supports all partners in an effective, efficient and inclusive manner. The revised partnership structure and processes will be more inclusive of all communities and more manageable for partnership staff. As much detail as possible toward this new structure and process should be completed by December 1, 2025.

ACTIONS

- Agricultural Advisory Committee Directive
 - Signed by all Executive Council members.
 - Will establish the first new advisory committee since the late 1980s.
 - The advisory committee will consist of farmers, including urban farmers, and other agricultural industry stakeholders, who will use their knowledge of farming operations and best management practices to directly advise the Chesapeake Bay Program on how agriculture can be part of the solution for a healthier Chesapeake Bay and watershed.

 Signatories to initiate planning that is responsive to the Beyond 2025 Phase 2 Charge
- Day Two Gather MB members: Jurisdictional and Federal members, and GIT and Advisory Committee chairs to agree on a general plan of action that is responsive to the 2024 EC Charge on Beyond 2025
- Day Three Convene MB members, GIT chairs, Signatories, and Interest Parties to identify considerations for the MB's draft plan of action for addressing the Beyond 2025 Phase 2 Charge, including the plan for public engagement and input



MB Retreat Decisions

Decision: The SRS Process has been modified to address the adaptive management needs of the partnership in 2025, acknowledging that documentation will look different this year and that the partnership will not hold Quarterly Progress Meetings in 2025.

Decision: In place of standard SRS documentation, Goal Teams will generate responses to the "Big Question": "What advice do you have for the Management Board on how to consolidate, reduce, update, remove, replace or add new outcomes within your Cohort/GIT?" utilizing the agreed-upon guidelines. (This is one of two pieces that takes the place of the "Impact Assessment" that was previously discussed)

Decision: The Management Board approved the general schedule and sequence of activities for execution of the Beyond 2025 Phase 2 through December 2025.






FY 2024 Budget Overview



FY 2024 EPA Chesapeake Bay Operating Budget







SWG Community Capacity Building Grants

- Builds the capacity of frontline organizations working collaboratively on community and watershed health goals
- \$13M over four years (\$3.5M for FY24)
- Administered by the Chesapeake Bay Trust

Examples of Other Grants Funded

- Advisory Committees (Stakeholders, LGAC/LLWG, and STAC) - \$1.27M
- Staffer Program and C-StREAM Interns - \$1.3M
- Partnership Communications/ Media Support - \$516k
- Water Quality and Living Resources Data Managers - \$288k
