With the 2014 Chesapeake Bay Watershed Agreement, our need for indicators to both communicate progress and manage performance has grown. Characteristics and qualities of a good indicator, as well as tools to determine whether an indicator provides the right information, will be discussed in this presentation, using several examples from Outcomes in the 2014 Agreement. Goal Teams can use this information in developing indicators, and STAR and Goal Teams can react to the indicator options presented for several specific Outcomes.
