**Field Trip Information:** Kingman and Hertiage Islands (<https://www.kingmanisland.com/>) are the product of dredging the Anacostia River over 100 years ago and are now home to important and rare ecosystems, including tidal freshwater wetlands, vernal pools, wildflower meadows, and tidal swamp forests. After Day 1 of the HGIT Meeting (5/1), DC DOEE will be providing an optional tour of Kingman and Heritage Islands and will highlight their work on ongoing wetland restoration projects.
