• BEYOND 2025:

- Mary Andrews: NOAA will be pressing for fish passage goals to be included in the new Chesapeake Bay Agreement. As noted, I'm sure USFWS will do so as well. The Workgroup needs to start thinking about what an appropriate goal is.
 - Jessie Thomas-Blate: It would be nice to support species for fish passage outside anadromous species.
 - Alan Weaver: Resident species and eels are always on our list of "targets" for fish passage projects.
 - Mary Andrews: The Workgroup modified our goal years ago to include resident fishes and eels. The real issue is the amount of funding dedicated to programs for these species. NOAA generally does not fund these since we are migratoryfocused due to our mission.
- Chris Guy: We may want to have a special Fish Passage Workgroup meeting when the Beyond 2025 report comes out. The Beyond 2025 Steering Committee members are asked to provide presentations and get feedback during the public comment period. This will be closed before our next meeting.

10:40 - CULVERT AOP GRANT PROGRAM

<u>Presenter</u>: Jim Earley (USFWS)

- PRESENTATION DESCRIPTION: Jim provided a presentation on the US Department of Transportation Federal Highway Administration's National Culvert Removal, Replacement, and Restoration Grant Program.

- COMMENTS/QUESTIONS: For more information, please contact Jim Earley (james earley@fws.gov).
 - Brett Towler: It's oddly specific that the program funds culverts and "weirs". Similar acts and programs may refer to "stream barriers", rather than weirs. Is there a reason why the weir language was used?

- Mary Andrews: The intent of the funds is to address fish passage associated with road and transportation infrastructure. DOT defined that as culverts, weirs, and even some dams. However, it has to have some connection to transportation infrastructure. It's using DOT's definition of a weir - DOT is not funding fish passage in general.
- Brett Towler: I was wondering if there was an intent to exclude any number of other stream barrier types (e.g. removal of partial breaches, notches, incised channels, piers) that could be found at transportation infrastructure.
- Mary Andrews: Yes, my understanding is if it's a fish barrier that is associated with transportation infrastructure, it would be eligible. "Weir" here is used in general terms.
- Jessie Thomas-Blate: VDOT is willing to work with folks on projects.

11:10 – STATE FISH PASSAGE COORDINATOR UPDATES: DAM REMOVALS & CULVERT PROJECTS Presentations provided by multiple speakers

PENNSYLVANIA:

- Dave Dippold was was unable to attend this meeting nor provide updates for PFBC.
- Jessie Thomas-Blate (American Rivers)
 - More than 50 dam removal projects in PA are in the works; not sure how many of those are within the Chesapeake Bay Watershed.
 - A well-attended dam removal project manager training was held in March in central/eastern PA near Allentown. There was lots of interest in projects in DE/Chesapeake basin. Hoping to get additional funding through TNC to continue trainings in the future.
 - Through this effort, we realized training is needed targeting specific entities (e.g., engineering-specific, regulatory aspects, etc.). There is a lot of interest from other agencies on more targeted trainings in the next several years.
 - PA is still the leader in dam removals in the Chesapeake Bay Watershed regarding the number of projects being removed.
