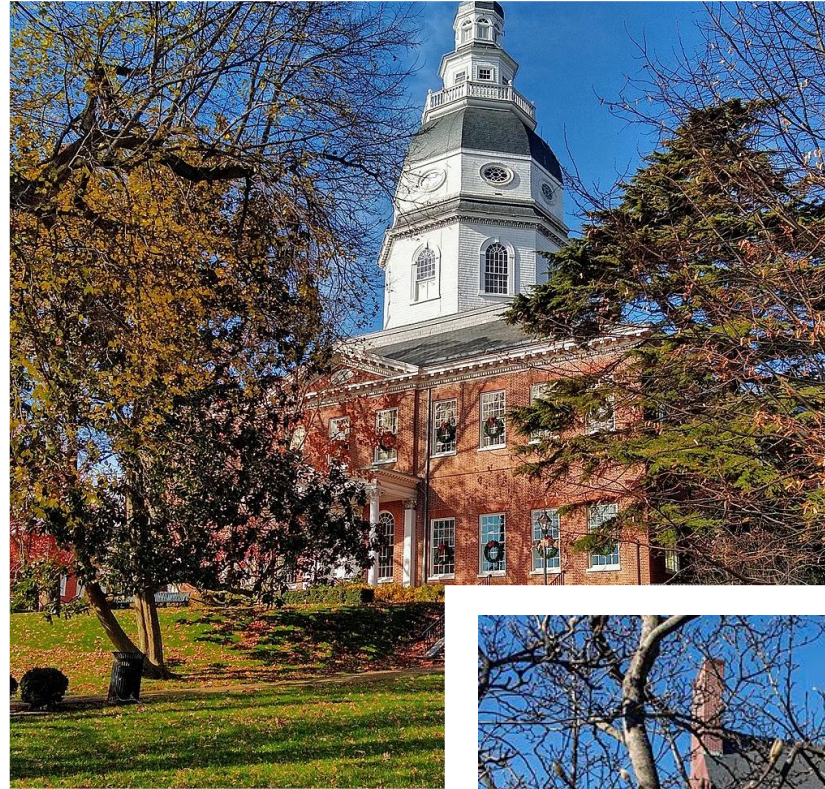

Recommended Executive Council Actions

Beyond 2025

- Recommend asking the Executive Council to issue a new charge to the Principals' Staff Committee:
 - By the 2025 meeting, prepare updates and edits to the vision, principles, existing goal statements and management strategies of the *Watershed Agreement*.
 - Beginning at the 2026 meeting, the partnership should review all outcomes and reaffirm, refine or refresh their scope to ensure they are specific, measurable and time-bound targets that contribute to achieving the partnership goals, ensure mutual commitment, provide strong direction to the partnership and continue to drive accountability and progress evaluation.
- Recommend that the Executive Council restate their commitment to the partnership, with the intent for continued and future collaboration.
