# LGAC Feedback on Vision, Preamble, Principles

- Vision, Preamble and Principles do not use plain language and are not easy for local governments to understand.
- Highly supportive of local government principle: Acknowledge, support and embrace local governments and other local entities in watershed restoration, conservation and protection activities.
- Consider adding additional language about economic and quality of life benefits

### **Land Use Outcomes**

# \*High Priority\*


- High resolution land use data is valuable to local governments
- But local governments may not know that land use data exists or how to use it. Some may need technical assistance to effectively use the data.
- Having examples of local policies and/or planning tools could be a valuable resource for local governments. Needs to be state specific.
- State and federal partners need to connect with local planners to 1) share high resolution land use data 2) provide technical assistance to use the data and 3) share best practices and case studies

# **Local Leadership Outcome**

# \*High Priority\*

- Strong support for continuing to 'increase the knowledge and capacity of local officials'
- A key commitment from state and federal partners to support local governments
- LGAC supports a stronger connection to the Local Leadership Outcome, but has concerns about an advisory committee leading implementation of an outcome





### **Climate Outcomes**

# \*High Priority\*

- A climate science framework should be applied across all outcomes
- Monitoring of changing environmental conditions continues to be critical
- Local governments need federal and state investments in adaptation practices and maintenance of those practices
- Practices that provide dual benefits for water quality and adaptation, like flood mitigation, should be prioritized



# Toxic Contaminants Outcomes \*Medium Priority\*

- Local governments are on the front lines of toxic contaminants and other environmental disasters
- Need to be realistic about the scale of toxic contaminant impacts, potential costs to local governments and the timeline required to address toxic contaminants
- Suggest that outcome language includes the phrase 'emerging contaminants' with or without a list of specific toxic contaminants

# Beyond 2025 - Phase II: LGAC Involvement to Date

#### December 2024 LGAC Meeting:

- Reviewed Executive Council charge
- Discussed process for updating the watershed agreement

#### January 2025:

- LGAC Leadership identified outcomes that were relevant to local governments
- Virtual LGAC member discussion on outcomes that were relevant to local governments

#### February - March 2025:

- Based on virtual discussion, LGAC Leadership drafted responses to 'pulse checks'
- LGAC represented at Management Board reviews of Outcome Assessment and submitted 'pulse checks'
