Beyond 2025 Engagement Strategy and Feedback Plan Draft April 25, 2024

Introduction and Purpose

In October 2022, the Chesapeake Executive Council <u>charged</u> the Principals' Staff Committee with recommending a critical path forward that prioritized and outlined the next steps for meeting the goals and outcomes of the <u>Chesapeake Bay Watershed Agreement</u> beyond 2025. To meet this charge, the Principals' Staff Committee directed the Management Board to form the Beyond 2025 steering committee, consisting of representatives from each signatory, core federal agencies, advisory committee chairs, Goal Implementation Team (GIT) representatives and two non-voting representatives with expertise in restoration and partnership.

In June 2023, a contractor was retained to assist in assessing the existing *Watershed Agreement* goals and outcomes, evaluate existing program implementation and processes described in resource documents (e.g., <u>Charting a Course to 2025, Comprehensive Evaluation of System Response</u>), conduct an organizational assessment of the existing partnership structure and perform a functional review of the Chesapeake Bay Program to assess what works effectively and recommend opportunities for improvement where challenges and barriers are found.

A few months later, five small groups were formed to guide the steering committee in preparing findings for critical topics: Clean Water, Climate Change, Healthy Watersheds, People and Shallow Water Habitats. Leading up to a two-day symposium in February 2024, these small groups, consisting of experts in each of these areas, each presented their findings to help support the next steps for moving beyond 2025.

Prior to the two-day symposium at the end of February 2024, each of the five small groups held listening sessions for any interested parties to provide feedback on their findings. Additionally, the Beyond 2025 steering committee co-leads, small group leads and other steering committee members have presented on their activities in this process to several GITs and workgroups and conducted briefings to higher-level Bay leadership.

Currently, the <u>small group</u> and the contractual findings are being synthesized to support a high-level recommendation regarding the *Chesapeake Bay Watershed Agreement* that will be made to the Executive Council at their December 2024 meeting.

The purpose of this engagement strategy and feedback plan is to document the approach the partnership plans to take in informing interested parties of the recommendation and supporting documentation that will go to the Executive Council in December 2024, as well as lay out the process for providing feedback to this document.

Goals

Taking advantage of opportunities throughout the May-June 2024 timeframe in which to inform interested parties about the process behind the Beyond 2025 effort, discuss the synethized small group and contractual findings, as well as planned next steps, will help ensure that this process

is understood, positioning interested parties to provide thoughtful and meaningful feedback when the draft recommendation and supporting materials are made available.

Target Audiences

For this initial feedback phase, the primary audiences are those that have knowledge and interest in the Chesapeake Bay restoration and conservation effort. These include, but are not limited to:

- Chesapeake Bay Program GITs, workgroups and advisory committees.
