Recap of Major Actions

Since July's meeting...

- Public Feedback was shared with Steering Committee as it was received and is still accessible from the Beyond 2025 Small Group SharePoint.
- Complete set of feedback was shared on September 5th and also publicly posted to CBP's Beyond 2025 webpage.
- Final Draft Revisions were shared with the Steering Committee by September 20th
- From July's SC meeting, breakout discussion and chat comments on scoping an Outcome Impact Assessment were synthesized and posted to July's meeting page.

Feedback Summary

Comment Statistics

- 81 total commenters (500 orgs/representative individuals); ~48,000 words
- 1,900 individual emails from two actions alerts (Chesapeake Bay Foundation & Waterkeepers Chesapeake)

Scope of Comments

- Notably, over a quarter of all relevant comments were most relevant to Phase 2 and the “how” of implementation. Important considerations and necessary to retain and utilize as Phase 2 initiates.

Comment Themes

- **Enhanced accountability and evidence-based** restoration practices.
- **Conservation as a focal area** and integration into pillars of restoration and science.
- **Address local and regional priorities** of climate resilience, env. justice, & “emerging” issues.
- **Importance of collaboration** and balancing needs across all partners.
- **Inclusive public engagement** to foster greater transparency and trust.
- **Technical assistance and financial support** to sustain and grow local implementation activities.

Guiding Principles for Revisions

Overarching philosophy...

- Strive to ensure the Steering Committee's intent was properly and clearly communicated.

Initial review of comment scope....

- Is it credible?
- Is it relevant to this process and the Bay Program?
- Is it related implementation / Phase 2?

Advancing for further consideration...

- Is it editorial?
- Was the matter discussed by the Steering Committee?
- Are there multiple comments that speak to the matter?
- Source of comment

Part I – Recommendations to the EC

EC #1

- Maintain momentum
- Adherence to Governance and Management Framework
- Timing of Agreement amendments [**For SC Discussion**]

EC #2

- Effective coordination, collaboration, inclusion when streamlining.

Additional Background

- Consideration of SMART approach
- Acknowledged existing challenges to accompany progress
- Emphasized land use and population growth

Part II – High Level Recommendations for CBP

Science

- Explicit mention of toxics and emerging contaminants
- Added language towards nutrient imbalances and non-point source issues.
- Revised language and additions for social science

Restoration & Conservation

- Conservation revised using NRCS's definition as well as SC feedback.

Partnership

- Clarified “systems” approach.



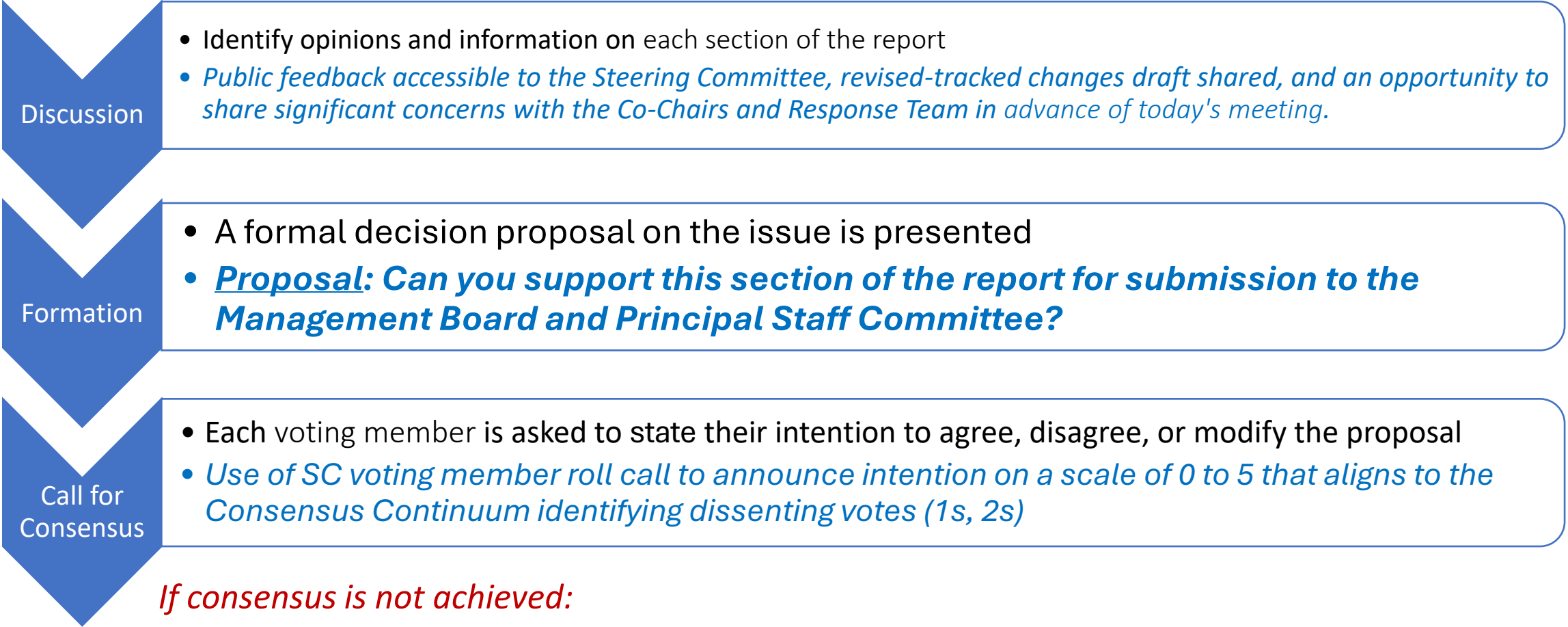

Consensus-building Process



Identify & Address Concerns	<ul style="list-style-type: none">• Dissenter(s) presents their concern(s), starting another discussion to address the concern.• Dissenter(s) supply an alternative proposal(s) or a process for generating one.
Modify Proposal	<ul style="list-style-type: none">• The proposal is amended to address concerns. Process returns to a call of consensus.• If consensus again is not reached, or if time runs out, we will discuss options at the end of meeting.

Consensus Review Process

Consensus Review Periods (~25-30 min each)

1. BLUF, Recommendation #1
2. BLUF, Recommendation #2
3. All other components of the Executive Summary
4. Synthesis Narrative: Science
5. Synthesis Narrative: Restoration & Conservation
6. Synthesis Narrative: Partnership

Call of Consensus

- SC voting members (or alternates) register your support using a consensus continuum scale 0 to 5, with option to skip/no vote
- If we meet consensus, we move on to next review
- If we have dissent (1's or 2's), we will use remaining time to discuss concerns, offer modifications, and work through consensus again

If we cannot get to consensus

- Those that registered a [1] or [2] raise their concerns and offer a modification; SC voting members register their support of the modification(s)
- If time runs out and we are still not at consensus, a volunteer works on a modification on the slide lines, or we consider removing the conflicting text from the report.
