

The Proposed Change

- Change our committee's name to Stakeholders' Advisory
 Committee
- Definition of "stakeholder," from Cambridge Dictionary: "a person such as an employee, customer, or citizen who is involved with an organization, society, etc. and therefore has responsibilities toward it and an interest in its success"

Why we Request This Change

- CAC has held leadership and accountability roles in the Program's Diversity, Equity, Inclusion, and Justice work.
- CAC's own membership has significantly diversified racially, culturally, geographically, and generationally in the past several years.
- With urging from the Stewardship Work Group, the Executive Council accepted revisions to the Watershed Agreement in 2022, removing or replacing the word "citizen."
- As the Program evolves beyond 2025, we expect a broader understanding of public involvement and the need to include a wider diversity of voices in our work.

The Process

- CAC members discussed this change over the course of a year and reached consensus in December 2022.
- The Executive Council must approved the new name before it can be officially adopted.
- CAC requests that this topic be included as an item in the Executive Council annual meeting in October 2023.
