Why Priority Topics?

- Subcommittee Names and Focus are member driven
- Annual subcommittee priority is the primary focus for the year
- Collectively drive the Quarterly Agendas for the Year
- Quarterly Meeting theme or spread throughout the year
 - Deep-dive with outside experts/practitioners
 - Seek to uncover a clear outcome
 - Lead to a recommendation or action
- Members can move to another subcommittee, serve on more than one, or create new one

Role of Subcommittees

Members

- Serve as ambassadors on a topic
- Identify key issues the Committee should understand in advance of the panel
- Help lead the discussion and ask questions of the panelists
- Help compile findings on takeaways from the discussion
- Bring recommendation or potential action for the Committee's consideration
- Determine aftercare and member roles in follow-up to the advice to the EC/PSC

Chair

- Represent the Subcommittee's interests on the Executive Committee
- Help draft and lead the Subcommittee Agendas

Water Quality Subcommittee

 Watershed Implementation Plan, CBP should divide the pollution loads among the jurisdictions

- to EC: urged implementation of the State Action Plans for Wetlands and Forest Buffers

Friendly Suggestions for Priorities

Narrow focus of the panel

Don't try to tackle the universe of the topic

Distribution of Effort beyond Chair and Staff

- Establish precise roles for each member
- Volunteer for specific responsibilities

Don't underestimate the need to ground the full Committee in the issue

- 2022- Extensive briefing document and 15 minute presentation not effective
- 2023- Low attendance on prep Learning Sessions
