#### VII. Update: TMDL Indicator and METRIC tool

The TMDL Indicator combines monitored and modeled data to estimate the progress of annual pollution loading rate reductions since 1995 in response to implemented management practices. The partnership recently updated the indicator and posted it to Chesapeake Progress. The indicator helps compare progress between different sources and locations and also facilitates communication of the progress to the Chesapeake Bay Program partnership and the public.

The Monitored and Expected Total Reduction Indicator for the Chesapeake (METRIC) is an application designed for visualizing the monitored load trend and CAST-estimated load trend for the Chesapeake Bay Non-Tidal Network (NTN) stations.
