# 9:35 Land Use/Land Cover Data (2024 edition): Rule Considerations and Class Names – Katie Walker (Chesapeake Conservancy)

Based on reviews of the latest version of the model, the LULC project team has an additional rule change we are considering to better align urban tree canopy calls with other research and mapping routines. We'd like to share this rule with the FWG for approval before integrating the change into the model. In addition, we'd like to update the naming of our forest and tree canopy classes, and would like feedback and ideas from the FWG.

CC will be supporting USFS with geospatial analyses that will be included in the State of the Chesapeake Forests 2.0 Storymap. These analyses will identify areas for new tree plantings and investigate the health of our forests through patterns of fragmentation. CC will be coordinating with USFS and USGS on proposed methods, using analyses performed for the Maryland Forest Technical Study as a basis.
