- II. **Update on EC Climate Directive Workplan** ( 1:05 p.m. – 1:30 p.m.)  
This session is a high-level update and overview of the partners' progress toward the Workplan, including jurisdictional and Federal commitments. It underscores how the partnership should organize itself and its resources to be more effective and strategic on climate work.

Background: In October 2021, the Chesapeake Executive Council signed Directive No. 21-1 Collective Action for Climate Change. The Directive acknowledges the consequences of climate change on Chesapeake Bay ecosystems and communities and commits the Chesapeake Bay Program (CBP) and partners to take concerted steps to address the impacts of climate change in all aspects of the partnership's work to restore the Chesapeake Bay and its watershed. In 2022, the partners issued a workplan to tie actions to the Directive.

**III. Priority Climate Science Needs** (1:30 p.m. – 1:55 p.m.)

An action in the EC Climate Directive Workplan states to *refine and prioritize climate science needs and develop a resource plan*. To support the prioritization step of this action, STAR worked with each outcome lead to compile one priority climate science need from each outcome. STAR will present on these priority climate science needs to 1) improve partnership understanding of the climate science needs and 2) identify how partner programs' expertise and resources could be further leveraged to address the priority climate science needs. Completing and addressing the climate science needs for all the outcomes will require a stronger engagement and collaboration from all partners.

Requested action: Concurrence from the MB that the partnership should move forward with these priority climate science needs and how their current efforts may support some of these needs. In addition, we request guidance on developing a resource plan to make progress on these priority climate science needs.

**V. Pausing the Strategy Review System Requirements for the 2025 WIP Outcome and Postponement of the September Clean Water Quarterly Progress Meeting (for Toxic Contaminants and Water Quality Standards, Attainment and Monitoring Outcomes)**

Due to the compressed schedule for completing work related to Beyond 2025 and preparing for the Executive Council meeting in December 2024, two decisions are being requested from the Management Board today: (1) temporarily pausing the Strategy Review System (SRS) requirements for the 2025 WIP Outcome given the Accountability Framework in place for the partnership's water quality goals and until an alternative path forward can be defined for how the SRS process can support attainment of the 2025 WIP Outcome and (2) postponing the September Quarterly Progress Meeting for the Clean Water Cohort (which also includes the Toxic Contaminants and Water Quality Standards, Attainment and Monitoring Outcomes) until later this year or in 2025.

- IX. Water Quality Accountability Framework Refresher** (3:20 p.m. – 3:50 p.m.)  
 The Chesapeake Bay Water Quality goal is being implemented using an accountability framework that guides restoration efforts using four elements: Watershed Implementation Plans (WIPs), two-year milestones, EPA’s tracking and assessment of restoration progress and, as necessary, specific federal actions if the Bay states do not meet their water quality commitments. Under the water quality accountability framework, the partnership requested EPA to conduct ongoing oversight of Bay states’ programs to ensure they are on track to meet the goals of their WIPs and two-year milestones. This session is refresher of the Bay TMDL, the water quality accountability framework and its ongoing implementation.
