Census of Ag: Chesapeake Bay Watershed Spotlight

Census of Ag

- April AgWG: presentation from NASS on 2022 Census of Agriculture
 - High-level; nationwide, only touching on CBW region
 - Watershed summaries will be released on July 24th
- This month: visualization of a subset of state- and county-level data; review of the use of these data

Poultry Industry Data

- Interest in adding poultry industry data as another “line of evidence” supporting modeling tools
 - Note: *Not* eliminating existing data sources
 - AgWG member lead: Paul Bredwell
- In March, heard from Mark Dubin about commercial agricultural production data decisions
 - The partnership has decided to incorporate commercial ag production data in the past

Recommendation to the AMT

- AgWG wouldn't figure out how these data are incorporated into the modeling tools
 - AMT is responsible for figuring out the “how” and making related decisions
- If the AgWG is in support of this effort, “thumbs up” can be given to the AMT to pursue this
