Chesapeake Bay Program Management Board Meeting - March 27, 2025

Outcome Disposition Meeting Consensus Results

The Chesapeake Bay Program's Management Board uses a consensus-based process for decision making (Chesapeake Bay Program Governance Document, page 22). "A consensus decision-making process is a group decision-making process that not only seeks the agreement of most participants, but also the resolution or mitigation of minority objections" (Chesapeake Bay Program Governance Document, page 21).

At its March 27, 2025 Outcome Disposition Meeting, the Management Board utilized the Consensus Continuum (Figure 1), described in the <u>Chesapeake Bay Program Governance Document</u> (page 23), and an outcome disposition agreement process (Figure 2). Management Board members submitted consensus continuum votes on behalf of their organization, agency or entity via a "pulse check" decision support tool constructed on Google Sheets. All Management Board members (voting and non-voting) were invited to participate. The results presented in this document were downloaded and summarized on March 28, 2025.




Figure 2. The outcome disposition process steps employed by the Management Board included an attempt at full consensus, discussion of alternatives, and if consensus could not be acieved, signatory supermajority voting. Consensus was reached for all outcome dispospositions. Singatory supermajority voting was not utilized. For additional details on this process, please see the <u>Consensus Agreement Process</u> presentation.


