#### **Open for Comments**

Opportunity for anyone to comment, particularly those that haven't had a voice within the Outcome discussions (i.e., interested public; partnering organizations)

#### **Pulse Check**

- Similar to Phase 1 Small Group Synthesis
- An online survey (or some other mechanism) for each MB member to walk through all Outcomes discussed, to determine what modification (update, combine, remove) should be considered for consensus.
- Take 15 minutes to complete Pulse Check
- In plenary, perform quick scan to review if any Outcomes have overwhelming support to move for consensus (NEXT SLIDES FOR MORE CONTEXT); identify discrepancy so parties can discuss in between meetings.

# Outcome Review Meetings – Pulse Check Options

#### Suggested survey options and general definitions.

"Update" = Outcome intent is largely kept intact. Unique language may be necessary if it is more than just a SMART update. Key principle is maintaining the intent.

#### If Consensus is reached

Such a determination would enable an Outcome to begin updating language immediately for review in April, and refinement in May.

"Consolidate" (i.e., Combine) = Multiple Outcomes would be combined in a single Outcome, or activities contributing to an Outcome are dispersed across others. Such a determination would be agreeing to the next stage in refinement. Because multiple permutations of consolidation or configuration could still occur, the exact reconfiguration is not needed until May. April would be the next time to revisit.

"Remove" = The Outcome is removed from the 2014 Agreement.

The exact post-life of such an Outcome is not necessary (e.g. considered an Indicator, Output, etc.). However, it does bring into question on how an Outcome's post-2025 progress will be evaluated, which should be a consideration during structure and operational alignment, and resource modeling.


# Other actions in the EC that could be final actions, but may not make sense at this stage...

- "Replace" This language suggests that a novel Outcome replaces a current one.
   That could take place later during April/May when gaps become clearer, but probably not appropriate at this stage.
- Reducing This language suggests that the total number of Outcomes are reduced, which is a culmination of multiple decisions. Unsure what "reducing" a single Outcome looks like, where this phase is trying to determine an action for each Outcome.
- Adding This step is about reviewing the current features of the 2014
   Agreement. Again, gaps may become clearer in April/May of what could be
   added as an Outcome, however, you could also think of that as "replacing"
   "removed" Outcomes.


## Outcome Review Meetings – Deliberation and Decision Framework

#### **Design Considerations:**


- Iterative, in order to allow time for reconciliation, and space for novel ideas, particularly with reconfiguring and rewriting Outcome language.
- Clear milestone, in order to continue progress and delineate focus for each component of Phase 2.

PSC MEETINGS UNDER CONSIDERATION
