- -David Norman/VCU commented on this text "As targets are almost reached, the last remaining acreage may become more difficult and/or expensive per acre of restoration on some tributaries." He asked for clarification. A: "Final mile delivery concept" provides some explanation as to why you have to restore in less optimal areas, after public process narrows down the available bottom to build reefs.
