SRS Options for WQGIT

1. Pass – only available to outcomes that are on track.
 1. N/A for 2025 WIP outcome
2. Brief 1-year update – Option to create a 1 year workplan to bridge to next year when we would be required to do a fully 2-year workplan
3. 2-year Update – Option to create a 2-year workplan now and then only need to provide a brief update next year.
4. Pause – this is not an official SRS option, but a suggestion at the May 13 WQGIT meeting.
 1. Would need approval from GIT 6 as well as the MB. If not approved, would still be expected to develop a 1 or 2 year workplan

COMMON CONCERNS (HEARD)

- What's the value?

Jurisdictions' WIPs and Milestones

COUNTERPOINTS

- The workplans are referenced internally and across Goal Teams – they fuel GIT funding proposals, workshop ideas, and more
- We have so much material already at our fingertips – let's use this opportunity to discuss, strategize and document common features or priorities
- A matter of adaptive management; accountability; transparency
- We have help
- We can keep it relatively simple
- The process enables broader discussions, especially at cross-GIT steps
