## Focus of the Annual Report

## Leadership of the Chesapeake Bay Program

- Executive Council (Collectively the Governors, DC Mayor, EPA, CBC)
- Principals' Staff Committee (Secretaries of Environment, Ag, Forests, Conservation, etc...)

### Why?

The EC and PSC are the **focal points of accountability** for the **Chesapeake Watershed Agreement** and improving water quality, living resources and habitats, and enhancing resource productivity of the Watershed.

## **Characteristics of Annual Recommendations**

## Issues the <u>full Committee</u> discussed in the past year

- Topics from quarterly meeting briefings
- Informed by multiple perspectives and learning from each other

## Limit to 3 topics

Avoid "hidden" or sub-recommendations

#### **Concise**

Detail focused on the advice and stakeholder view of the impact

#### **Actionable**

- Beyond an expression of appreciation or concern
- Not posing another question or simply requesting information

## Recap: 2022 Recommendations

## (1) Accountability for the 2025 Deadline (WQ)

- hire agency staff to enforce existing regulations, target priority practices with co-benefits, and provide technical assistance for implementation
- "Crisis of Credibility" accountability for the TMDL and Goals of the Watershed Agreement

## (2) Volunteer Stipends (S&E)

 Address a barrier of inclusive engagement and advance the CBP's commitments to DEIJ by providing stipends to eligible volunteers of ACs and Workgroups

## (3) Large-Scale Solar Development (CLU)

 coordinate a watershed-wide approach to protect the high-quality ecosystem functions, sustainable agriculture, and water quality targets
