# Getting from "A" to "B25"?

How will we get from individual recommendations to a path forward for the Program?

- Define a set of standard information to gather for each recommendation
   one page per recommendation.
- 2. Combine recommendations as appropriate.
- Categorize recommendations based on whether they impact our Agreement, our Partnership, both, or neither.
- 4. Measure and record level of consensus or comfort within steering committee around pursuing each recommendation in Phase II.
- Determine the scope of the work ahead with these recommendations in mind

# Recording and Measuring

- All small group recommendations, after combining and standardizing, will be collected and shared in the appendix of the SC's product.
  - Significant time, thought, and discussion went into each of these recommendations.
  - All of them, to varying degrees, will be in the minds of the SC and the broader Bay community as we propose a path forward.
- We will do a pulse check, using the Consensus Continuum, for each recommendation to help the drafters highlight where there is significant strength of support and where more conversation would be needed.
  - We will use polling software and document the results in the appendix.
  - This information should be helpful for Phase II.



#### **Beyond 2025 Small Groups**

#### **DRAFT Recommendations to the Steering Committee**

February 26, 2024 (Updated w/ Climate Recommendations)

#### **Shallow Waters**

#### 1. Climate-Resilient Restoration

Prioritize system-scale shallow water habitat restoration that provides social, economic, and ecological benefits while also providing resilience and connectivity under changing land-use and climate conditions.

#### 2. Integrated Modeling and Monitoring

Improve understanding of connectivity and habitat function under changing conditions by expanding Chesapeake Bay and watershed monitoring and modeling to include continuous shallow water habitats.

#### 3. Adaptation Strategy to inform Habitat Management and Project Planning

Implement a process for climate adaptation in shallow water habitats that integrates adaptation science and community engagement elements. Primary steps include conducting vulnerability assessments and modeling habitat transitions under alternative future scenarios, engaging the community in setting priorities for planning, implementing measures at both local and system scales while sharing knowledge, and evaluating the effectiveness of the measures to improve the desired outcome.

#### 4. Communication and Engagement

Strengthen the connection between people and shallow water habitats by communicating the importance of these ecosystems and their socio-economic benefits to stakeholders. Develop active and sustained engagement with communities to understand their values and utilize social science strategies to develop stewards of their local waterways. Align actions and funding to these values and socio-economic considerations.

#### 5. Effective Governance, Collaboration, and Innovative Funding

Shift the effort, resources, and accountability evenly across the outcomes. Prioritize product over process and adjust outcomes and funding accordingly. Manage shallow waters as an interconnected ecosystem that leverages collaboration among the Bay Program partnership and organizational structure.







- Integrated periods between SC drafting, review, and revisions


