Review of November 2023 feedback

Submersion Series

- o Overall, WQIGT members said the Sub Series is meeting their expectations & needs
- Opportunities for improvement:
 - More transparency/input in the prioritization of topics. Potential concern for scope-creep outside of the WQGIT scope & purpose on some of these.
 - Continuation of discussion/insights/follow-up during WQGIT monthly calls. Link back to partnership decision-making is slightly unclear.

• Scope/Purpose

- WQGIT members are satisfied with our scope & purpose as it's currently stated.
 - On a scale of 1 (re-write our scope & purpose) to 10 (make no changes), members ranked it a 7.2

• Agenda/Time Distribution

- Members ranked the following as the ideal balance of WQGIT time in 2024 2025:
 - ullet 26% Cross-partnership issues, priorities, tools, policy, or implementation
 - 23% Model updates, inputs or development
 - 20 % Monitoring & verification
 - 16% Planning, adaptive management, or governance
 - 15% Emerging or misc science

- Future topics/briefings in existing parking lot (Phase 7, Beyond 2025, etc.)
 - Summer 2024 update on Multiple Tributary Models (MTMs), with an emphasis on the policy/implementation level; update on changes to the Main Bay Model

 - Coordinated review or overview of indicators/reporting?
