#### **Discussion:**

Tyler Trostle: We had a question about RI practices that need to be reported in acres and not just in feet, and how we can go about getting a change in the [NEIEN] Appendix to adapt this. Specifically, RI practices being exclusion fence with forest buffer or grass buffer, exclusionary fence from narrow forest buffer, buffer on watercourse RI, forest nutrient exclusionary on watercourse narrow RI, as well as buffer on watercourse RI and grass nutrient exclusionary upland watercourse narrow RI.

Olivia Devereux: Those are all BMPs that are in the NEIEN Appendix and can be reported in units of feet or length or width, they are not (according to the current appendix) allowed to be reported in acres although in CAST they are converted to acres. It might be easier for PA to report the actual acres since that's what ends up in CAST anyway. The NEIEN Appendix is locked down in the end of August, so let me clarify that Tyler is proposing a change for the 2024 progress year. We could go ahead and start to make edits to the appendix for the next progress year and add those BMPs in with the allowable unit of acres.

Tyler Trostle: Correct.

Olivia Devereux: I think Tyler is proposing that and asking for agreement to make that change for 2024, not affecting this progress year.

Tyler Trostle: Correct.

Alicia Ritzenthaler: Just to confirm, we'd still be able to report in feet if we wished?

Olivia Devereux: Yes, it doesn't take anything it just adds another option. We currently have some states that report BMPs in units called 'AC' for acres and others that report using 'Acre' and it's the same BMP just with Unit Accepted as 'AC' or 'Acre'. Each state has their own tracking system with their own preferred units and in this case it's in there as feet and Tyler

wants to report with acres which matches how PA is tracking it and doesn't remove anything already in the appendix.

Cassie Davis: If that's something that needs to move through WTWG for approval we can have it be on our next agenda item.

Alana Hartman: We actually had a problem this year with entries for length and width for buffers causing a weird issue (load increases) in CAST, so we had to re enter them as acres. If anybody else had a bunch of buffers entered as length and width you might want to check your results and make sure they are as expected.

Jessica Rigelman: I've noted Tyler's request as well as a few others that Bill Keeling has made for next year's NEIEN Appendix. I will continue to gather them and present them as normal in July for the new appendix approval for August 2024. I don't know if it needs to be at our next meeting because I'll have them all consolidated into one set of requests before the next progress.

Olivia Devereux: If anyone is going to have heartburn about it and would anticipate not approving it I would ask that they speak up before August so that Tyler can do appropriate planning for reporting in advance. I don't anticipate anybody would have a problem but who knows.
