

Management Board Meeting May 19 2016

Actions & Decisions

I. Program Updates

<u>Decision</u>: The Management Board (MB) approved the Habitat Goal Team's (GIT) recommendation that the current leadership of the GIT serve as co-chairs rather than as chair and vice chair.

II. Chesapeake Bay Accountability and Recovery Act (CBARA)

<u>Action:</u> The Bay Program will distribute to the MB and PSC the letter received from the Office of Management and Budget (OMB) that requests funding information from the states "to the extent available." MB members should recall that the public was told to expect funding information to be released in September in lieu of rushing to provide it in the workplans themselves.

III. Businesses for the Bay

<u>Decision:</u> The MB agreed to become a partner of the Alliance's Businesses for the Bay (B4B) program.

IV. Water Quality Issues

a. Process to Address BMP Policy Issues

<u>Decision</u>: The MB agreed to hold a special meeting of the MB to focus on policy issues reported out by the Oyster BMP Expert Panel. Participants will include MB members, Advisory Committee members, as well as other invited experts.

Action: A revised version of the document outlining the process for addressing policy issues identified by the BMP expert panels will be distributed to the MB. The revised version will reflect the edits captured during the MB discussion. MB members will have two weeks to review the document and suggest additional edits. The document will be discussed again at the June MB meeting.

<u>Action</u>: Agreed that the MB should be provided with a list of any policy issues stemming from the BMP panels prior to each MB meeting.

b. BMP Panel Memo

<u>Decision</u>: The MB approved the BMP Expert Panel Memo with the following edit made during the MB meeting:

"If 'late-hit' comments are received outside of this 30-day comment period, either right before or during a decisional meeting with no notice to the Expert Panel and Source Sector Workgroup Chair/Coordinator of an objection, leadership from the Source Sector Workgroups and the WQGIT

should feel empowered to adhere to the BMP Expert Panel Protocols and or move the draft report forward to the next approving partnership group."

Request: A MB member requested that the BMP Panel Memo become a standing item on future MB agendas to keep members abreast of progress.
