- II. **Chesapeake Bay Program Funding for Monitoring** (10:15 a.m. – 10:40 a.m.)  
During the February PSC meeting, the CBP partners were asked to assess the level of funding needed to improve the capacity of CBP monitoring programs. The traditional CBP water quality and living resource monitoring networks (i.e., tidal and nontidal water quality, SAV and benthic macroinvertebrates) have been reduced and stressed while accommodating inflation, program vulnerabilities and flat funding over the past decade. Currently, management needs exceed network capacities with some long-standing gaps and the PSC wants to improve them. CBP leadership is developing a plan to address the PSC request and will share it with the MB. The plan includes providing: (1) An evaluation of our current networks' capabilities and vulnerabilities; and (2) Information on what is needed to improve the monitoring networks that includes incorporation of new tools, data collection and data evaluation methods. This activity will be led by STAR and the Integrated Monitoring Workgroup.

The Climate Resiliency Workgroup will provide an overview of several projects currently underway that will help identify what we know and don't know about BMP performance under changing climate conditions. The CRWG is looking to use the information from these projects to help develop a BMP climate change research agenda. The workgroup will be seeking MB feedback on: 1) how to prioritize BMP climate (taking into consideration which which BMPs are most vulnerable to climate change; have the most water quality benefit; have the most co-benefits); 2) how to fund BMP climate change research; 3) What role might the Climate Action Team play in getting support for BMP climate change research? (This action was granted an extension until the April 8<sup>th</sup> Management Board Meeting at the request of the CRWG.)
