Update on Progress

Request: Agencies with credited BMPs in the 2019 Progress scenario were asked to:

- Comment on the overall completeness and accuracy of the data
- Provide a complete historical BMP record (if readily available)
- If a complete historical record does not exist, provide 2020 Progress submission

Fish and Wildlife	USFWS provided a complete list of BMP USFWS clarified they also possess land in WV
GSA	GSA does not have resources to provide complete record 2020 progress submission requested

Smithsonian	No response received
Forest Service	No BMPs credited to agency in 2019 Progress; contacted 9/14
