

### **Verification Definition**

"Verification: the process through which agency partners ensure practices, treatments, and technologies resulting in reductions of nitrogen, phosphorus, and sediment pollutant loads are implemented and operating correctly."

### **Role of Local Governments**

- Engage with the lead state agency(s) to ensure existing local BMP tracking, verification, and reporting efforts are directly reflected in the states'/the District's enhanced verification program
- Re-examine stormwater management programs in light of the guidance for enhancing verification of stormwater management practices and treatment systems
- Be vocal in terms of how to best ensure a full accounting of pollutant load reduction actions taken in a way that help ensures continued functionality

### **Resources Available**

 Source sector specific BMP verification guidance within the basinwide framework document

 States'/District's Chesapeake Bay grants include funds to support development of enhanced BMP verification programs

 University (e.g., VA Tech consortium of land grant universities) and contractor (e.g., EPA's Tetra Tech contract) resources available to assist local jurisdictions to assist in the design of statistical surveys
