

Commodity Land Uses

- Producers report all acres of harvested, small grains through the Ag Census.
- All acres of small grains fit into the Small Grains and Double-Cropped land uses.
- If use of commodity cover crops expand, 2017 Ag Census should capture the expansion.

Overlapping Practices

- Q5. Can cover crops be combined with other practices to treat runoff from agricultural land uses?
- A5. Yes. For example, a single acre of cropland could be eligible for reduction credits from conservation tillage, manure injection, nutrient management, cover crops and upslope reductions from buffers.
- Equation: Pre-BMP Load X ((1 Practice 1 Efficiency) X (1 Practice 2 Efficiency) X (1 Practice 3 Efficiency) X...)

Next Steps

- Phase 5.3.2 practices have been mapped to new practices; no changes needed from states.
- WTWG should:
 - review all reported Phase 6 practices
 - eliminate unnecessary practices from reporting options
 - add necessary practices as requested by states
- States always have the option of revising historical data to better reflect new practices (e.g., traditional cover crops with fall applications).
