# Top Comments, Questions, and Issues To Date

- ▶ Concerns about adopting the Conowingo WIP (CWIP) without the financing strategy in place
- ▶ How pay-for-performance translates to the farmer
- ▶ Questions about the dredging opportunity to meet the CWIP goals and outcomes
- ▶ A desire to see more involvement from Exelon Corporation
- ▶ More flexibility on Best Management Practices (BMPs) across the primary geography
- ▶ Concerns about additional load reduction in counties where they are already at capacity on BMP implementation goals toward PA Phase 3 WIP
- ▶ Concerns about competition with Phase 3 WIP for cost-effective opportunities
- ▶ Concerns about lack of local capacity to take on additional responsibility
- ▶ Concerns about potential competition for urban BMP implementation opportunities within Phase II MS4 communities in Maryland
- ▶ Concerns about CWIP integration with the Nutrient Management Program in Maryland
- ▶ Questions regarding tracking/reporting implementation, how projects will be separated from the Phase 3 WIP, who is responsible for making that decision, and who is responsible for verification
- ▶ Concern in New York about the geography being too limiting, primary areas have been a focus in the past
- ▶ Questions about the origins of the target loads associated with the Conowingo Infill, how the modeling was conducted, and why sediment is not included in the target

# Financing Strategy Structure

- ▶ Financing Strategy Assumptions
  - Chesapeake Bay Program Partnership will have ultimate responsibility for funding
  - Public Funding alone will not be sufficient
  - Restoration success will require public/private partnerships
- ▶ Enabling Conditions
  - Efficiency
  - Scale
  - Durability
