8:30 **Delaware and Pennsylvania Pilot Cover Crop Transects** Marcia Fox/Susan Richards The established crop residue transect programs in Delaware and Pennsylvania for tracking and reporting county scale cropland tillage management implemented a new cover crop pilot project in late 2014. Marcia Fox with DNREC and Susan Richards with the Capital Area RC&D Council representing both programs will present the findings of their respective pilot cover crop programs, the methodology used in conducting the surveys, and how the information is being proposed to track and report annual cover crop implementation for the two

jurisdictions. Delaware and Pennsylvania are requesting workgroup review of the methodology for approval for future progress reporting to the Chesapeake Bay Program.

### 10:30 Poultry Data Update

The recommendation report of the Poultry Litter Subcommittee identified the urgent need to enhance the currently available poultry production and litter data being utilized by the Chesapeake Bay Program's modeling tools. A regional effort was consequently launched between the partnership and the poultry industry to explore new opportunities to develop new publically available data on an annual basis. Mark Dubin with the University of Maryland and Christian Richter with the US Poultry and Egg Association will provide an update on the progress that is being accomplished to realize this joint goal for the Phase 6.0 modeling tools.

- 11:00 Region 3 EPA Animal Agriculture Program Evaluation Report Kelly Shenk/Mark Zolandz Kelly Shenk and Mark Zolandz with the EPA Region III Water Protection Division will provide a summary of topline findings from EPA's Animal Agriculture Program Assessments conducted in Maryland, Delaware, and West Virginia (assessments for NY, PA, and VA were released in March) and discuss the utility of the Bay state assessments to the Agriculture Workgroup.
- 11:30 Phase 6 Land Use Loading Rates Gopal Bhatt/Tom Jordan/Gene Yagow/Jack Meisinger In response to the preliminary findings of an AMS scientific review of the Tetra Tech recommendation report providing suggested land use loading rates and citations for the Phase 6.0 modeling tools, a scientific review committee was established through Virginia Tech. CBPO Modeling Team member Gopal Bhat will provide a short introduction to how the Phase 6.0 modeling tools will represent land use loading values. Committee Chair Tom Jordan with SERC, Project Principle Investigator Gene Yagow with Virginia Tech, and Jack Meisinger with USDA-ARS will present the committee's findings regarding Phase 6.0 agricultural land use target loading rates for nitrogen, phosphorus and sediment for the workgroup's review and approval.

consensus opinion could not be reached on a specific element of the full report, the Workgroup Chairs elevated the workgroup's opinions to the Water Quality Goal Implementation Team for consideration. The WQGIT took up the discussion during their team meeting on September 14, and decided to withhold a decision on the panel recommendations. The WQGIT instead requested that the workgroup move forward with establishing an ad hoc to evaluate how the jurisdictions may represent their existing nutrient management program in future progress reporting. The Workgroup Chairs will discuss the next steps for the panel report, and the establishment of an ad hoc subcommittee for providing its findings to the WQGIT in October.
