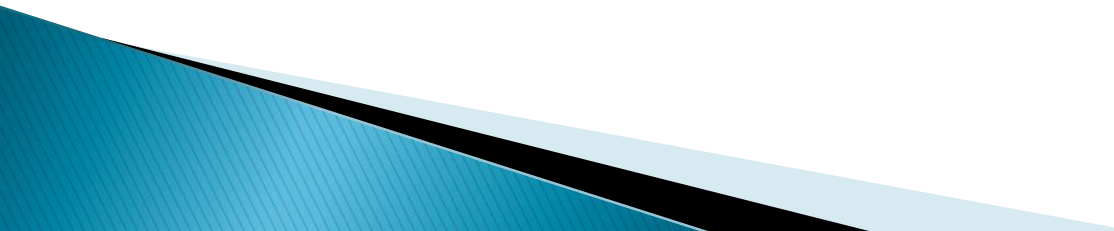

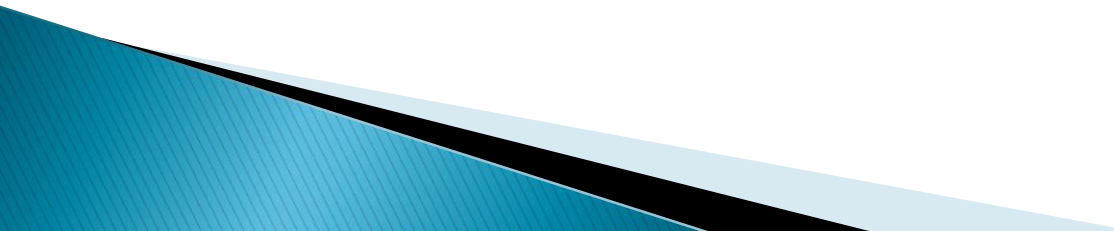

- ▶ All panelists and interim invited WTWG modelers are now members of one or more subgroups.

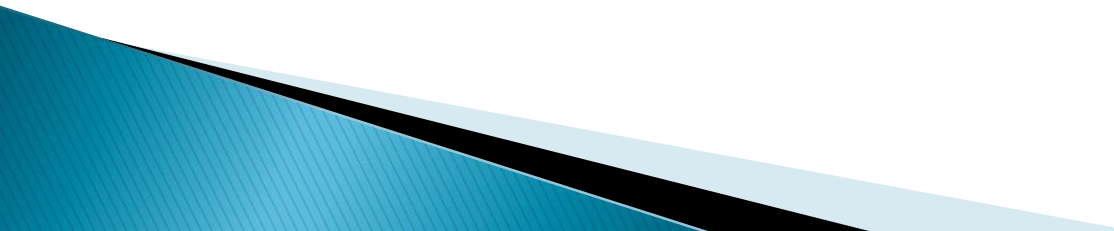
Subgroup Activities

- ▶ Majority of panel activities will be occurring in smaller subgroups
 - ▶ Modeling subgroup has been expanded to include additional jurisdictional modeling representatives on an interim basis
 - ▶ Modeling subgroup will be reviewing an interim proposal for representing NM as an efficiency
 - ▶ Modeling sub-group conference call has been scheduled for Friday, March 9 with the CBPO modeling team

Subgroup Activities

- ▶ Nursery subgroup has been actively engaged in a review of existing nursery data and identifying opportunities for improved reporting
 - ▶ Cropland subgroup will be scheduling a conference call to select a chair and develop a scheduled process for reviews

Schedule

- ▶ **December:** Tt starts literature search. Panel selection.
- ▶ **Early February:** Panel conference call. Interviews and collection of program info.
- ▶ **Mid-Late February:** Summary of interviews.
- ▶ **Late February:** Citations/abstracts for retrieved literature–first draft. Summary of program information.
- ▶ **Mid February:** Consult with modelers on BMP incorporation.
- ▶ **Mid March:** Panel initial findings to AgWG.
- ▶ **Mid March:** Preliminary information for use in Phase 2 WIPs.
- ▶ **March–June:** Panel continues research on BMPs. Prepares for reviews and approvals.
- ▶ **June:** Final recommendations from Panel.
- ▶ **June/July:** Source Sector Review.
- ▶ **July:** Technical Review.
- ▶ **July/August:** Approval meeting for WQGIT.
- ▶ **August/September:** Final report
