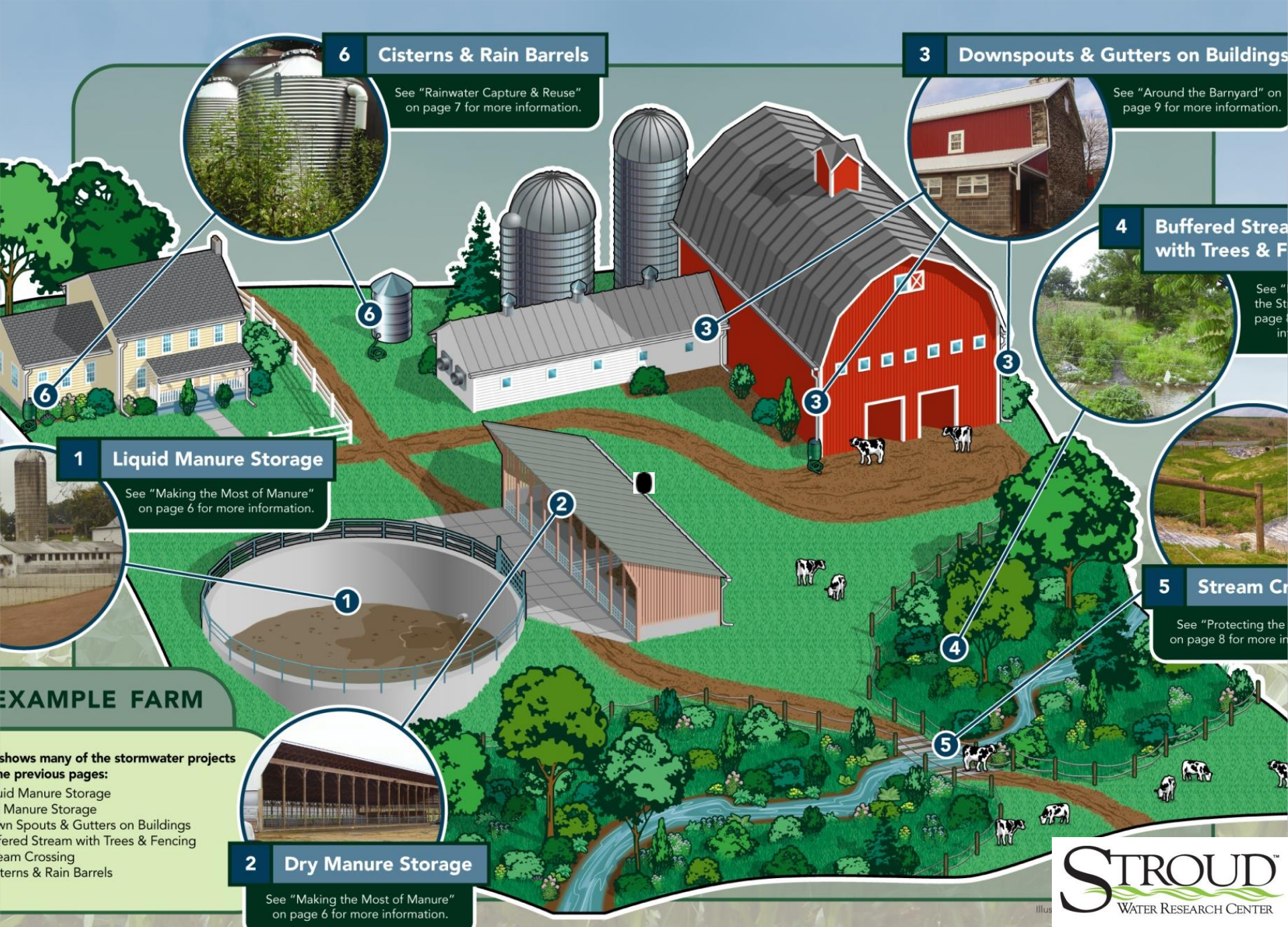

# How the program works

- “Voucher” earned on forest buffers  
35’ or wider forest buffers - \$4k/ac (\$20k max)
- Full compliance with ag regulations
- Whole farm conservation: implement BMPs



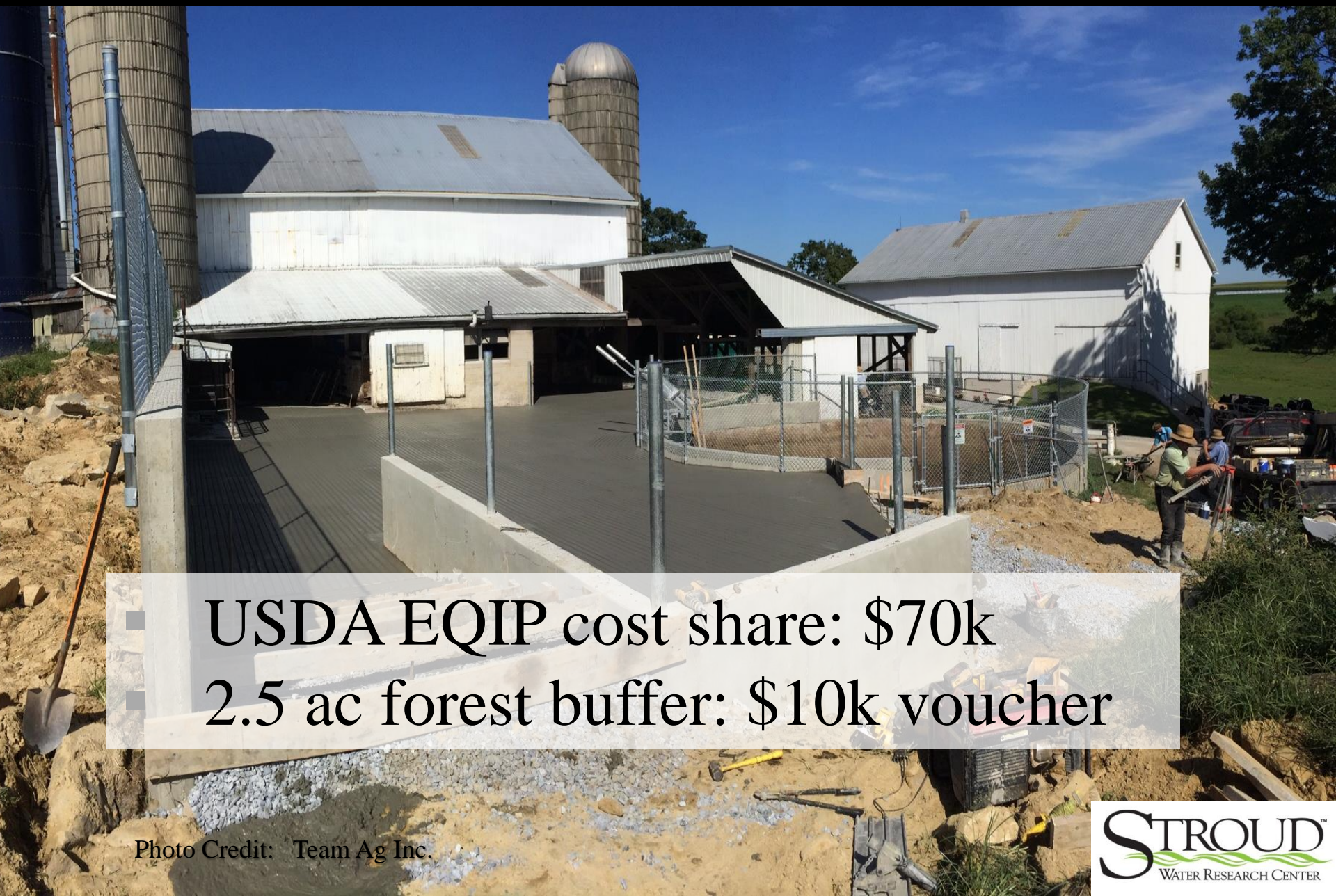
# Example of voucher use

- Barnyard near stream with manure runoff issues
- BMPs to fix: \$80k

# Example of voucher use



- USDA EQIP cost share: \$70k
- 2.5 ac forest buffer: \$10k voucher

# Leveraging Resources

Parable of the Wise Steward:

Spend someone else's money

- Federal funds: USDA EQIP, RCPP, CREP
- State funds: PennVest, REAP
- Grant funds



# Funding for Farm Stewardship Program

Funds passing through Stroud Center

Grant funding:

9 grants in 3 years: \$3.55M

- National Fish and Wildlife Foundation (NFWF)
- PA DEP Growing Greener
- William Penn Foundation



# Outcomes of Farm Stewardship Program

CHESTER County per farm averages (10 farms):

- 3.2 acres of buffer/farm
- 54' avg buffer width (one side)
- 9 ag BMPs (~ \$60k+ in EQIP, RCPP, etc.)
- Whole farm compliance at TMDL levels
- \$14k CREP funds/farm

*Ask for more...and you can get more*



# Outcomes of Farm Stewardship Program

**BERKS County** per farm averages (14 farms):

- 4.4 acres of buffer/farm
- 81' avg buffer width (one side)
- 16 ag BMPs (~ \$70k+ in EQIP, RCPP, etc.)
- Whole farm compliance at TMDL levels
- \$20k CREP funds/farm

*Ask for more...and you can get more*



# Outcomes of Farm Stewardship Program

LANCASTER County per farm averages (14 farms):

- 4.6 acres of buffer/farm
- 70.5' avg width (one side)
- 8 ag BMPs (~ \$60k+ in EQIP, RCPP, etc.)
- Whole farm compliance at TMDL levels
- \$21k CREP funds/farm
