<p>Independent Evaluator Function Update (Discussion Lead: Greg Allen)</p> <ul style="list-style-type: none"> Updates on progress made in reacting to the Chesapeake Bay Accountability and Recovery Act. 	<p>1:50-2:05</p>	<ul style="list-style-type: none"> https://www.congress.gov/bill/113th-congress/senate-bill/1000 The Independent Evaluator Function Workgroup has been meeting regularly to discuss the implications of the Chesapeake Bay Accountability and Recovery Act of 2014 on the Independent Evaluator of the Program. A process and timeline for responding to the new law is being developed; however, there are questions about the availability of funding and the different kinds of procurement mechanisms that are available to fund the independent evaluator. The workgroup is initiating a meeting with EPA to get answers to these budgetary questions. Kirk Havens recently met with Representative Wittman to address some of the questions that were raised: <ul style="list-style-type: none"> What does "independent" really mean? "Independent" implies that the evaluator will not be a federal agency or someone who is recently retired from a federal agency. How will the evaluator be funded? Rep. Wittman suggested that he put authorizations in the federal agency budget beyond EPA's budget to provide funds for this effort. What does "may nominate" mean? This wording implies that eligibility for being the evaluator is not exclusive to institutes of higher ed., but he and Senator Warner strongly prefer an institute of higher ed. Rep. Wittman will attend and speak at the next STAC meeting.
