GRANTS AND GIFTS RECEIVED

Since 1982, \$456,380 of gifts and grants to support the Extension Vegetable Field Research and Demonstration has been received. These monies come from seed companies, ag chemical companies, food processors, the Delaware Department of Agriculture, The Pennsylvania Department of Agriculture, and The Delaware Potato Board. The money is used for specific work on variety evaluation, cultural practice research, herbicide evaluation, and other related research programs. The results are published or disseminated through various

publications, reports, or presentations that are reflected throughout the dossier.

Since 1999, Pickle Packers International, Inc., a trade organization, has supported the Pickle Harvesting Improvement Program, as well as associated programs with grants of \$5,000 per year.

In 1992, a Hatch Project was approved for \$2,200 for Yield Improvement of Lima Beans in Delaware. This was renewed in 1993.

In 1988, with support of Delaware Vegetable Producers, a line item of \$30,000 was established by the Delaware Legislature to support Extension vegetable work. This line provides total support for the Extension Associate - Vegetable Crops position. In 1996, it was enhanced to \$116,000 to support the Extension Plant Pathologist Position held jointly with the University of Delaware and the University of Maryland. In 1998, this line was increased to support the Extension Associate: BioResource Engineering position. In 2000, it was increased to \$216,000 to support the Extension Irrigation Engineer position. The creation and enhancement of this line reflects the cooperation between growers, the vegetable industry, the University, and the Delaware General Assembly to support the Delaware's Vegetable Industry. The positions created also support other segments of Delaware's Agriculture and The University of Delaware's Cooperative Extension Mission.

In 2001 and 2002, \$145,000 and \$60,000, respectively, in grant funds were received to conduct research in Speciality Crops from the USDA and the Delaware Department of Agriculture. I wrote the proposal that shared the funding with faculty and staff to conduct research in plant disease control, best cultural practices, and mechanical harvest improvement. The funds were especially useful in developing disease control strategies.
