9:00 a.m. Walking Tour of Virginia Capitol Grounds – Greening Virginia's Capitol

On Capitol Square, the terraced brick steps were replaced with permeable pavers, a series of rain gardens were installed within the Capitol Square and bus loop to collect and filter rain water and prevent erosion. Rain water is collected in an underground storm tank at the south corner of the Square and used to irrigate the grounds. The project employs a combination of LID techniques to create a "green" corridor along 10th Street from Bank Street to Cary Street, and converts two alleys into "green alleys" using permeable pavers, within blocks of the Square. Estimated pollution reduction will be shared as a part of the tour.
