## IV. Continuing Efforts to Engage State Depts. of Education Leaders (11:05 a.m. - 11:50 a.m.)

A discussion about continuing efforts to engage state departments of education leadership to advance environmental literacy, including their plans to use the *Every Student Succeeds Act of 2015* to aid state efforts. The new law includes authorizing language for more than \$1.5 billion in grants for which environmental literacy programs are eligible. CAC would like the partnership to consider options for motivating jurisdictions to develop plans and to apply for the funding. In addition, CAC would like the partnership to consider the value and feasibility of revising Education Directive 98-1 to more consistently engage these leaders in addressing the 2014 Chesapeake Bay Watershed Agreement.

<u>Action</u>: Seeking a MB recommendation to the PSC for actions to advance environmental education through greater involvement in the CBP by state departments of education and to promote efforts for securing funds through the *Every Student Succeeds Act*.
