In an effort to reduce the polluting effects of stormwater on regional waterways, Prudential Financial is investing \$1.7 million towards a new pilot collaboration between The Nature Conservancy and Encourage Capital called District Stormwater LLC (DS). Projects funded through the program will generate Stormwater Retention Credits (SRCs) under DC's new Stormwater Credit Trading Program and help demonstrate how innovative financing can reduce or supplement public spending on water infrastructure.
