Who decides: Each signatory, partner, and interested stakeholders

How is the decision made: Unilaterally, by each signatory or stakeholder, via Goal Implementation

Discussion 3: Adoption of Management Strategies

Who decides: Management Board, based upon recommendations of Goal Implementation Teams. How is the decision made? (a) consensus of MB members?, (b) consensus of those MB members who will actually participate in execution of the management strategies? (c) if no consensus, voting

by MB members?, or (d) if no consensus, voting by those MB members who will actually participate in execution of the management strategies?
